## 2025 National Average Medicare Coding and Payment Rates for PICO<sup>®</sup> sNPWT:

### Hospital Inpatient

The American Medical Association has established two CPT codes for Single Use Negative Pressure Wound Therapy (sNPWT): **97607** and **97608**

Medicare does not separately reimburse hospitals for the PICO (sNPWT) when it is furnished to patients in the inpatient setting. Payment for the PICO (sNPWT) is included in the MS-DRG payment.

NOTE: Payment rates from non-Medicare payers will depend on each hospital's contract with each payer. Ensure that reported charges reflect both the PICO (sNPWT) and, if appropriate, the work to assess the wound, apply it, and provide instructions for ongoing care.

### Hospital-based Outpatient Department (HOPD)-Wound Clinic

Medicare has assigned CPT codes **97607** and **97608** (single use negative pressure wound therapy) to Ambulatory Payment Classification (APC) Group 5052 Level II Debridement and Destruction with a status indicator of T (procedure or service subject to multiple procedure reduction), provided that the NPWT service is medically necessary.

Please be sure to check with your patient's individual health insurance provider to ensure coverage, coding, and payment requirements are met for the site of care and provider.

Medicare has assigned CPT codes 97607 and 97608 (single-use negative pressure wound therapy) with a status code of “A” meaning these codes are paid separately under the physician fee schedule, if covered. There will be RVUs for codes with this status. The presence of an “A” indicator does not mean that Medicare has made a national coverage determination regarding the service; carriers remain responsible for coverage decisions in the absence of a national Medicare policy.

## 2025 National Average Medicare Coding and Payment Rates for PICO<sup>®</sup> sNPWT: Home Health Agency

Effective January 1, 2024, you may now bill for Single Use Negative Pressure Wound Therapy (sNPWT) using HCPCS code A9272 on Type of Bill (TOB) 32X for the device only.

Home health agencies receive a separate payment for negative pressure wound therapy (NPWT) using a disposable device, such as PICO Single Use Negative Pressure Wound Therapy System, for Medicare beneficiaries who receive home health agency services under a home health plan of care. These services may be performed by registered nurses, licensed practical nurses, physical therapists, or occupational therapists that are permitted to perform wound assessments under state law.

Note: Claims for sNPWT sent on TOB 34X with CPT codes 97607 or 97608 and claim on or after January 1, 2024 will be returned to the provider. In addition, nursing and therapy services related to the application of the device will be reported on TOB 32X and are no longer separately billable, as they are included in the home health bundled payment. ## 2025 National Average Medicare Coding and Payment Rates for PICO<sup>®</sup> sNPWT:

### Important reminders:

#### Suggestions when using single use negative pressure wound therapy “sNPWT” eg PICO sNPWT:

1. Verify that sNPWT codes 97607 and 97608 are listed on your Charge Description Master (CDM)
2. Verify the HOPD charges for sNPWT codes 97607 and 97608 **include the combined charges for the PICO device and for the work** to assess the wound, to apply the PICO device, and to provide instructions for ongoing use
3. Verify that the charges for 97607 and 97608 are different than the charges for 97605 and 97606 (which should not include a charge for the NPWT durable medical equipment)

**CAUTION:** Many HOPD Charge Description Masters mistakenly cross-walk the same charges from 97605/97606 to 97607/97608. This fails to capture the cost of the PICO device in the HOPD charges for 97607 and 97608. Understanding the importance of updating your CDM for sNPWT to ensure charges reflect the fact that sNPWT always includes the purchase of the device, while Traditional Negative Wound Therapy (tNPWT) does not.



## Reimbursement Helpline

Before applying PICO<sup>®</sup> Single Use Negative Pressure Wound Therapy System, all HOPD's should confirm or clarify coverage and coding from each patient's insurance plan, as each payer may have differing formal or informal policies or decisions.

#### Indications for use

PICO Single Use Negative Pressure Wound Therapy System is indicated for patients who would benefit from a suction device (negative pressure wound therapy) as it may promote wound healing via removal of low to moderate levels of exudate and infectious materials. PICO 7 Single Use Negative Pressure Wound Therapy System is suitable for use both in a hospital and homecare setting.

#### Appropriate wound types include:

- Chronic
- Acute
- Traumatic
- Subacute and dehisced wounds
- Partial-thickness burns
- Ulcers (such as diabetic or pressure)
- Venous leg ulcers – the PICO 7 System can be used in combination with graduated compression therapy in the management of venous leg ulcers
- Flaps and grafts
- Closed surgical incisions



PICO single use negative pressure systems are suitable for use both in a hospital and home care setting.
